The back road from the city of Washington to the southern states also runs through the land, which renders it an eligible stand for a tavern, it is also a good stand for a store. There are several houses, with a well of excellent water on this land, which lies well for cultivation, and has a considerable quantity of wood on it. The plaster of Paris also appears well adapted to the soil, as I raised fine clover on it from the application of that manure only.
