To F. C. Rorabaugh, Sheriff of Prince William County, Greetings:

WHEREAS a petition of such qualified voters of the Town of Manassas, Prince William County, Virginia, (a town of not less than one thousand inhabitants) equal in number to one fourth of the number of persons voting at the preceding regular municipal election, has been presented in vacation to me, J. B. T. Thornton, Judge of the Circuit Court of the said County, praying that an election be held in the said Town of Manassas on the question of granting or not granting a liquor license therein: Now, therefore, it is hereby ordered that an election be held in the Town of Manassas on the 19th day of March 1908, on the said question, and you, the said F. C. Rorabaugh, Sheriff as aforesaid, are hereby ordered to post notices of said election at three public places in the said Town of Manassas, including the voting precinct therein, and that you also give notice to the other officers charged with the duty of conducting other elections at the Manassas Precinct.
